

Reduced emissions = reduced costs


Fast payback on simple measures



Cutting Energy Waste: Where to Start







Start with visibility. You can't manage what you don't measure. A clear baseline helps identify 'energy leaks' – from unnecessary lighting and inefficient motors to compressed air losses and process scheduling



Energy Resilience: Managing Risk and Continuity

Diversify energy sources

Develop backup plans for grid instability

Explore on-site generation (e.g. solar, CHP)

Consider battery storage for peak protection

Build flexibility into your energy contracts



Are you ready for the upcoming energy price increase?


Pass-through charges are rising — but you might be able to offset them.
